Candidate Sherri Jackson NOT a resident of House District 22

Documents demonstrate that Jackson is constitutionally prohibited from representing District 22, and that her claims of residency are a sham

ANCHORAGE, AK—Documents recently obtained by Liz Vazquez for State House demonstrate beyond any doubt that Republican candidate for House District 22, Sherri Jackson is not an eligible candidate for the office she seeks. Ms. Jackson has not, as the Alaska Constitution requires, resided within District 22 for one year prior to her candidacy.

In fact, the undeniable evidence reveals that Ms. Jackson still does not reside within the District and never has. Ms. Jackson's claims of residency are a sham, attempting to get around the effects of last year's redistricting.

Ms. Jackson is not a qualified candidate for House District 22:

The Alaska Constitution requires that a candidate for the Legislature must reside within their district for “*at least one year, immediately preceding [his or her] filing for office.*”¹ Ms. Jackson filed her Declaration of candidacy on May 21, 2014—meaning she had to permanently reside within District 22 no later than the same date in 2013.

Ms. Jackson did not reside within District 22 on May 21, 2013, but in District 21—where she still resides to this date.

Immediately following last year's redistricting Ms. Jackson falsely claimed her place of employment as her “residence”:

Ms. Jackson resides at 3626 Casper Court in Anchorage—an address only one-quarter mile outside of District 22. She has resided here for at least a decade. In fact, in 2004, Ms. Jackson ran for Anchorage Assembly from this address.²

On July 14 of last year, the Redistricting Board adopted its 2013 Proclamation Plan, finalizing the boundaries of House and Senate districts for the 2014 elections. This Proclamation Plan placed Ms. Jackson's home in District 21. In response to this event—*just two weeks later*—Ms. Jackson and her husband changed their voter registration address from Casper Court to the business address of her part-time employer, Manor

Management, Inc., a provider of federally-subsidized low income housing to senior citizens.³ This company's address is conveniently located within District 22.

Ms. Jackson's change of residency appears to have been a transparent ploy to obtain residency within District 22 for the purpose of running for the House. Nevertheless, she failed to even make this false change to her residency by the May 21, 2014 deadline the Alaska Constitution demands.⁴

The evidence and authorities demonstrating that Ms. Jackson resides in District 21 are overwhelming and cannot be disputed:

- Ms. Jackson requested and received a *residential* exemption to property taxes for the years 2013 and 2014 at the Casper Court address pursuant to AMC 12.15.015(E)(1).⁵ That provision requires that the exempted real property have “been owned and occupied as the primary residence and permanent place of abode of an eligible applicant for at least 185 days in the year prior to January 1 of the exemption year.” Ms. Jackson claimed this exemption both before *and after* changing her residency on her voter registration to a different address.⁶
- The District 22 address at which Ms. Jackson *claims* residency is actually the address of her part-time employer. If this employment ends, she will no longer have any tie to District 22 and Alaska Statutes specifically provide that a “work site” is not one's place of residency.⁷
- The telephone number Ms. Jackson *currently* uses for her campaign,⁸ is registered as the telephone number to the District 21 residence, located on Casper Court.⁹
- Documents filed by Ms. Jackson during a run for office in the 2004 municipal election apparently stated her address as the Casper Court residence.¹⁰ Ms. Jackson's circumstances have not materially changed since that time. Publicly available information indicates that since 2001 she has held part-time employment at the location she now falsely claims is her residency address.¹¹

- Ms. Jackson obtained a State of Alaska Resident Sport Fishing Permit on June 22, 2013, claiming her address as 3626 Casper Ct., Anchorage, Alaska 99502 further demonstrating her mailing *and residence* address outside District 22 within the 12 months preceding her candidacy.¹²
- Ms. Jackson renewed her vehicle registration with the State of Alaska Division of Motor Vehicles on November 29, 2013 (after changing her voter registration), with a “*residential*” address at Casper Court.¹³
- Ms. Jackson’s Declaration of Candidacy states she’s been living at her employer’s address since “9/30/2012”¹⁴ and yet in November 2012 she requested an absentee ballot stating her residence is Casper Court.¹⁵

The uncontested and incontrovertible evidence establishes that Ms. Jackson does not reside in District 22. Ms. Jackson is not qualified under Art. II, Sec. 2 of the Alaska Constitution to represent the District.

Response from Ms. Jackson’s opponent, Republican candidate for House District 22, Liz Vazquez:

“I’m all for some healthy competition, but the plain fact is that Ms. Jackson simply cannot lawfully be elected to represent a District in which she does not live,” said Ms. Vazquez. “Ms. Jackson’s attempts to ‘game the system’ by claiming her workplace as her residence should be rejected by the voters of District 22. Even more disturbing is the element of dishonesty raised by these issues: Either Ms. Jackson is lying on her declaration of candidacy *or* she is falsely obtaining a residential tax break from the city and falsely obtaining federal housing benefits intended for low-income seniors, as well as making false statements to the Alaska DMV and Fish and Game.”

“Ms. Jackson has also given the Division of Elections two different stories—She swears on her declaration of candidacy that she has resided in District 22 since September 2012, yet an absentee ballot request form she signed on November 2012 states her correct District 21 address as her residence. I hereby call on Ms. Jackson to come clean about her deceptions, to apologize to the residents of House District 22 and to withdraw from this race.”

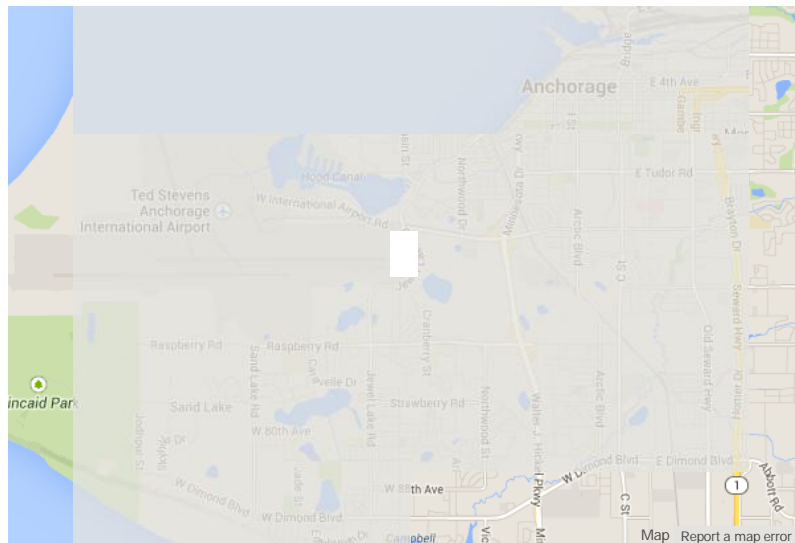
