Executive Summary: This email puts the Governor's office on notice of allegations of unlawful access by the Alaska National Guard to confidential police rape reports that contain intimate details about <u>civilians with no military affiliation</u>. This secret National Guard program used federal funds to help state official's access confidential police files that they normally would have been unable to access without a Court order or statutory authority. Your and the Governor's immediate attention to this matter is requested.



I am an Attorney in Washington DC who has been retained by a member of the Alaska National Guard who wishes to disclose gross misconduct to the Governor (via you) and likely commence a lawsuit against numerous officials who have engaged in constitutional rights violations. MG Katkus is fully aware of this situation and has been for some time but apparently has failed to take action so that is why I am escalating this to you (and the Governor). This email will likely be introduced as evidence of notification of the Governor of these serious allegations as such I am requesting a return email confirming receipt of this email.

My client loves the National Guard and doesn't want to bring it shame but feels he is being victimized in retaliation for his prior unwillingness to perjure himself during the National Guard Sex Scandal witch-hunts (those allegations will be saved for another day). My client is eager to quickly settle his dispute with the National Guard for a mutual confidentiality agreement & no money just assurances he will be left alone till he can retire; a settlement that should be a no brainer for the State given the breadth and depth of corruption we are aware of.

Please consider this email a formal report of misconduct by members of the Alaska National Guard to the Governor/Commander in Chief.

On or about 10 June 2014, I received from an Alaska National Guard Official a confidential police report that as I understand Alaska Law (I am not an Alaskan attorney) should not have been in the hands of anybody who was not a sworn law enforcement officer or otherwise entitled by State Statute to possess it (See AS 12.62.160 and Alaska Code 13 AAC 68.320). This report was contained in a federal administrative file of all places, available for thousands of federal employees to access and read without restrictions. The Anchorage Police Department

Even more shocking is this report was widely distributed amongst the highest levels of the Alaska National Guard in addition to countless others at low and mid-levels within the Alaska National Guard who say nothing wrong with it being attached to federal administrative records without knowledge. This report should have been safeguarded from public records and Alaska National Guard possession because #1 it contained the most confidential/private of details #2 it contained information on police policy and procedures for and #3 the allegations were later deemed by the police department to be "unprovable" after an extensive criminal investigation involving numerous civilian police officials; thus the alleged suspect should not be subject to vigilantism by others (in this case vigilantism by the Alaska National Guard), the very reasons for the laws that keep these records secret (See Alaska Statute 12.62.005 which states the intent of the law to limit access to police records that did not result in an arrest is to "protects victims of crime, allows the proper administration of justice, and avoids vigilantism")
As you can see from the attached documents, the National Guard has secretly been able to access confidential police files on civilians with no military affiliation without being a "criminal justice agency" as defined by AS 12.62.900 or engaging in "criminal justice activities" as defined by AS 12.62.900. Nor does any law specifically allow the two named Alaska National Guard officials to have access to not result in an arrest (interestingly to me these people claim a right to police files because they are "responsible for coordinating with and providing advice to Commanders regarding disciplinary actions" – guess what? How many other government entities have people who provide "advice" to decision makers about administrative disciplinary actions? This is a slippery slope - why aren't the people who work in the Department of Transportation and Public Facilities who advise low level managers on administrative disciplinary actions give access to these confidential police reports? (probably because such conduct is illegal? But again what do I know? I am not an Alaska Attorney). The attached documents are shocking in their sheer boldness, while the National Guard concedes they can have access to public records (i.e. Court documents etc); they want exactly what the law doesn't allow them, "police reports provide us with essential elements of offenses to determine the severity of those offenses, as well as witness statements" (quoting from the attached).
The attached documents show that the Anchorage Police in apparent contradiction of early statements from your administration about the original Alaska National Guard sex scandal and how hard it was to obtain evidence has given the National Guard unrestricted access to its records and has been far from uncooperative – if anything they are complicit in the Constitutional rights deprivations of civilians. Furthermore, the attached documents show that the Alaska National Guard did not hide the reason for wanting to obtain these confidential records – they wanted them to engage in vigilantism (i.e. administrative disciplinary action even when the Police didn't make an arrest)!!
Based on these allegations, I would like to know when the Governor first got briefed on the secret National Guard program to access on civilians without the victim's consent? Why didn't he object to this outrageous invasion of privacy for the civilian victim and other civilians who provided "witness statements" thinking these records would be confidential?
Why wasn't the Governor not shocked that hundreds of National Guard folks were able to read without MG Katkus and other key leaders putting any type of internal controls on their distribution?
Why has the Governor not demanded the resignation of MG Katkus, BOI/PR/LE/FPA, and the State Judge Advocate (amongst many other senior National Guard officials) who knew or should have known about this program for months if not years but did nothing to stop/end it? Is it because the Governor ultimately approved of this secret plan? Does the Governor, given these allegations, still have trust and confidence in the judgment, integrity, and wisdom of MG Katkus and BOI/PR/LE/FPA?



this program? If not, you are approving of this program – in either case it is a political issue for
September/October/November to be sure!



Alaska Guardsmen Train Alongside U.S. Marines, Mongolian Armed Forces

Military units share battalion level expertise during command post exercise in Mongolia

FIVE HILLS TRAINING AREA, Mongolia—More than 50 service members from the Alaska Army National Guard, U.S. Marines and Mongolian Armed Forces sharpened their command and operations skills while strengthening U.N. military-to-military relationships during a command post exercise at Five Hills Training Area, Mongolia this week.

The command post exercise was part of Khaan Quest 2009, a multinational peacekeeping operations training exercise running from Aug. 3-25. Other activities during the exercise include a U.N. peacekeeping seminar, a field training exercise, a humanitarian civic activity and a medical readiness training exercise. In addition to U.S. and Mongolian military units, participants and observers from other countries in the Pacific region are involved in the exercise.

The Alaska National Guard's annual involvement in the exercise is driven by the National Guard Bureau's State Partnership Program, which pairs the Alaska Guard with Mongolian forces. This was the first time the U.S. Marines' 1st Tank Battalion participated in Khaan Quest, according to commander Lt. Col. Tom Gordon.

"It's been a remarkable experience and a great opportunity for the Marine Corps to deploy and visit a country that most Americans will never have the opportunity to see," Gordon said. "We've built partnerships with our Mongolian counterparts and friendships that I'm sure will endure."

Training in battalion staff level operations during the command post exercise supports the Mongolian defense reform program's goal to establish and globally deploy battalion assets in peacekeeping operations in accordance with NATO standards. As the Mongolian and U.S. participants worked together side-by-side, they developed cohesive battalion-level mission plans.

Col. Ontsgoibayar Lkhamgii, commander of the 150th Peace Security Battalion, said the training was beneficial as his unit transitions to the NATO style of unit operations.

"This is just a taste of how a battalion staff functions," Lkhamgii said. "We look forward to using the troop leading procedures we've learned and applying this expertise in future training."

Alaska National Guardsman Lt. Col. Simon Brown, an operations officer from 38th Troop Command based at Ft. Richardson, served as one of the U.S. battalion commanders in the exercise. Brown explained that while the U.S. participants offered insight on battalion staff planning and operations, their Mongolian counterparts shared expertise in peacekeeping operations.

"It's been an exchange of ideas. We've trained the Mongolians on the military decision-making process, and shown them how to analyze a mission and then direct an operations order," Brown said.

Scenarios were based on U.N. peace support missions such as convoy operations, cordon and search operations, and establishing checkpoints and food distribution sites. U.S. and Mongolian battalion staff officers and non-commissioned officers would respond to scenarios by developing and writing mission operations orders. They would then send those orders to integrated ground troops who would execute the mission using a virtual simulation program.

Contractors from the San Diego-based company, Cubic Applications, coordinated simulation support, scenario design and small network infrastructure to support the exercise. The controllers operated the simulation program, Virtual Battlefield Simulation II, which would appear on laptops the ground troops would operate in rooms separated from the command cells.

William Vallandingham works for Cubic Applications contracted through the 3rd Marine Expeditionary Force in Okinawa, Japan. He was the lead designer of the command post exercise.

"The virtual simulation program provides a cinematic view of operations," Vallandingham said. "The story unfolds on screen so participants are responsive and engaged."

Mongolian Armed Forces 1st Lt. Gansukh Erkhembayar had used a virtual simulation program in previous training and was excited about the opportunity to once again train in a virtual environment.

"All soldiers should use this program before a mission," said Erkhembayar. "It is very good training."

While the focus of the command post exercise is operational training, fostering relationships at all ranks is the underlying theme of the exercise.

Capt. Travis Carlson, 1st Tank Battalion, 1st Marine Division said that besides training together, the participants spend their free time getting to know each other and sharing experiences at evening cultural events at the training area. Carlson's counterpart was Mongolian Armed Forces 1st Lt. Munkh-Od Binderya. Together they served as logistics officers in the battalion staff.

"We'll see these guys again. The world that we're in today, I wouldn't be surprised if I bumped in to him [Binderya] somewhere through a joint partnership in another country," Carlson said. "This makes it easier to work together somewhere else."

Khaan Quest 2009 will continue at the Five Hills Training Area, Tavan Tolgoi, and the city of Ulaanbaatar, Mongolia. The purpose of Khaan Quest is to increase interoperability and planning expertise among participating nations, and to further develop the Mongolian Armed Forces' training center at the Five Hills Training Area.

FORT RICHARDSON, Alaska -- Two paratroopers from Fort Richardson have been killed in Afghanistan.

The Army identified the victims as Staff Sgt. Clayton P. Bowen and Pfc. Morris L. Walker, both infantrymen. Officials say they were killed Monday when their vehicle was destroyed by a roadside bomb.

The 29-year-old Bowen was from San Antonio, Texas. He joined the Army in April 1998 and was assigned to the Anchorage base in February.

The 23-year-old Walker was from Chapel Hill, N.C. He joined the Army last September, and was assigned to Fort Richardson in March.

Guardsmen Meet Mongolian Counterparts for Upcoming Deployment

Alaska Soldiers observe training, develop relationships prior to mission in Afghanistan

FIVE HILLS TRAINING AREA, Mongolia—Two Alaska Army National Guard Soldiers are taking advantage of a rare opportunity to meet with the Mongolian troops they will embed with next month in support of Operation Enduring Freedom in Afghanistan.

Maj. Wayne Don, of Eagle River, and Master Sgt. Eric Schlemme, of Anchorage, are scheduled to deploy mid-September as U.S. liaisons with the Mongolian Expeditionary Force. The unit will provide base security at Camp Eggers for approximately six months.

Don and Schlemme were able to travel to Five Hills Training Area outside of Ulaanbaatar, Mongolia as part of Khaan Quest 2009, a multinational peacekeeping operations training exercise running from Aug. 3-25. The Mongolian Expeditionary Force is conducting simultaneous training at the Mongolian Armed Forces training center to prepare for their deployment.

Don and Schlemme are the sixth rotation of Alaska Army National Guardsmen to volunteer to deploy with the Mongolians. The previous five rotations have all been to Iraq. The first rotation of Alaskans kicked off the partnership in April 2004. The liaison program is part of the Alaska National Guard's ongoing relationship with Mongolia through the National Guard Bureau's State Partnership Program.

Normally embeds from the Alaska National Guard don't get a chance to meet with their receiving unit until deployed in country, so Don and Schlemme were pleased to meet their Mongolian counterparts now. They've been spending time meeting with key leadership, observing training and building relationships with members of the unit.

"We're both excited about working with the Mongolians and looking forward to a good deployment," Don said. "It's a really unique opportunity to deploy as advisors to a foreign army."

The Alaska Guardsmen will be the Mongolians' direct link into the U.S. command at Camp Eggers. They will work as tactical advisers, provide consult on base security operations, and serve indirectly as mentors — offering insight to the U.S. command structure and operational tempo.

The Mongolian Expeditionary Force is a unit compiled of approximately 130 elite soldiers selected by Mongolian Armed Forces Maj. Javkhlanbayar Dondogdorj specifically for this deployment. He will have a dual role in Afghanistan: serving as the commander of the Mongolian Expeditionary Force and as the senior officer over four Mongolian contingents.

Dondogdorj previously deployed with an embedded Alaska Guard liaison, Lt. Col. Stephen Wilson, who is currently the Alaska National Guard's state partnership coordinator. Dondogdorj said having an embedded liaison benefits the Mongolian unit.

"They resolve challenges, logistics problems and help with communication with the U.S. command," Dondogdorj said.



Guardsmen Meet Mongolian Counterparts for Upcoming Deployment

Alaska Soldiers observe training, develop relationships prior to mission in Afghanistan

FIVE HILLS TRAINING AREA, Mongolia—Two Alaska Army National Guard Soldiers are taking advantage of a rare opportunity to meet with the Mongolian troops they will embed with next month in support of Operation Enduring Freedom in Afghanistan.

Maj. Wayne Don, of Eagle River, and Master Sgt. Eric Schlemme, of Anchorage, are scheduled to deploy mid-September as U.S. liaisons with the Mongolian Expeditionary Force. The unit will provide base security at Camp Eggers for approximately six months.

Don and Schlemme were able to travel to Five Hills Training Area outside of Ulaanbaatar, Mongolia as part of Khaan Quest 2009, a multinational peacekeeping operations training exercise running from Aug. 3-25. The Mongolian Expeditionary Force is conducting simultaneous training at the Mongolian Armed Forces training center to prepare for their deployment.

Don and Schlemme are the sixth rotation of Alaska Army National Guardsmen to volunteer to deploy with the Mongolians. The previous five rotations have all been to Iraq. The first rotation of Alaskans kicked off the partnership in April 2004. The liaison program is part of the Alaska National Guard's ongoing relationship with Mongolia through the National Guard Bureau's State Partnership Program.

Normally embeds from the Alaska National Guard don't get a chance to meet with their receiving unit until deployed in country, so Don and Schlemme were pleased to meet their Mongolian counterparts now. They've been spending time meeting with key leadership, observing training and building relationships with members of the unit.

"We're both excited about working with the Mongolians and looking forward to a good deployment," Don said. "It's a really unique opportunity to deploy as advisors to a foreign army."

The Alaska Guardsmen will be the Mongolians' direct link into the U.S. command at Camp Eggers. They will work as tactical advisers, provide consult on base security operations, and serve indirectly as mentors — offering insight to the U.S. command structure and operational tempo.

The Mongolian Expeditionary Force is a unit compiled of approximately 130 elite soldiers selected by Mongolian Armed Forces Maj. Javkhlanbayar Dondogdorj specifically for this deployment. He will have a dual role in Afghanistan: serving as the commander of the Mongolian Expeditionary Force and as the senior officer over four Mongolian contingents.

Dondogdorj previously deployed with an embedded Alaska Guard liaison, Lt. Col. Stephen Wilson, who is currently the Alaska National Guard's state partnership coordinator. Dondogdorj said having an embedded liaison benefits the Mongolian unit.

"They resolve challenges, logistics problems and help with communication with the U.S. command," Dondogdorj said.

Schlemme hopes to also bring the spirit of the non-commissioned officer corps to the unit. The Mongolian Army is in the process of transitioning their structure to increase the responsibility of NCOs.

Alaska Guard Participates in Family Support Exchange with Mongolians

U.S. and Mongolian military leaders and spouses share ideas for supporting families

FIVE HILLS TRAINING AREA, Mongolia—Alaska National Guard and Mongolian Armed Forces leaders and spouses exchanged ideas on caring for and supporting soldiers' families at a conference in Ulaanbaatar, Mongolia Aug. 22-23.

The family support conference coincides with Khaan Quest 2009, a multinational peacekeeping operations training exercise at Five Hills Training Area Aug. 3-25. More than 20 Americans and Mongolians gathered in a community room at Star Apartments to discuss concerns Mongolia faces and look into aspects of the U.S. family support system Mongolia may want to adopt.

The conference brought experts on family support issues to Mongolia from Alaska, where conditions are very similar to Mongolia in many respects. Senior military leaders from the U.S. Army, Army National Guard, U.S. Air Force and Air National Guard also attended to present their perspectives on the importance of various aspects of family support. It was the first time the Alaska National Guard and Mongolia exchanged ideas on this issue.

Discussions explored several facets of family support in the United States, including family readiness groups, volunteers, chaplains and support from the business community. Participants also talked about the impact officers, non-commissioned officers and spouses can make within family support programs.

Lt. Gen. (Alaska) Craig E. Campbell, whose scheduled retirement date is Aug. 31, was able to take military leave from his position as Lieutenant Governor of Alaska to attend the conference as a traditional part-time Guardsman. In order to formalize the family support network that currently exists within Mongolian military families, Campbell recommended military leaders and spouses request support from the Ministry of Defense.

"If the Ministry of Defense doesn't provide support, it will continue to be an informal program," Campbell said. "It takes the leadership of the organization to validate what these families are doing."

The group focused on how family problems are frequently magnified when soldiers are deployed far from home on extended deployments. Leaders explained that when a casualty occurs, proper care for the casualty and support for the casualty's survivors is critical; aiding families in grief can minimize damage to unit morale and can avoid projecting a damaging image of the military into civil society. All of these factors could affect possible future recruiting and retention, as well as funding, especially in a democratic society.

Jan Myers, Alaska National Guard state family program director, said that as Mongolia's Armed Forces becomes increasingly professionalized and as Mongolian military units undertake increasingly more and larger international missions abroad, the issue of family support will become more critical.

"If they have a program that's back in their hometown taking care of their family, their mind will be in the right place and increase safety for all," Myers said.

Lt. Col. Batbold Isheekhuu, senior officer for strategic planning with the Ministry of Defense, said that with deployments for the Mongolian Armed Forces on the horizon, now is a good time to consider formalizing a family program.

"I found that it would be very good to have such a program to support the families of soldiers," Isheekhuu said. "It's a good time to gather information about the American Army and Air Force family support program."

But Isheekhuu also noted that current Mongolian culture and perception brings challenges; it would be difficult to obtain funding, recruit volunteers and engage businesses for support.

Among the group of U.S. experts who responded to these concerns was Lt. Gen. Richard E. "Tex" Brown, retired U.S. Air Force. Brown is the former deputy chief of staff for personnel at Headquarters, U.S. Air Force and assistant vice chief of staff for the U.S. Air Force. He explained that it only takes one person to start an effort and shared stories of how the United States overcame negative views of the military and developed family support systems since the Vietnam War.

Brown described how Lt. Gen. Gregory "Hal" Moore's wife initiated family support in the United States during the Vietnam War.

When Julia Compton Moore saw the impersonal casualty notification process -- a taxi driver handing a death notice telegram to a Soldier's spouse -- she told the driver to start bringing the notices to her directly. She then began delivering notices herself to be on hand to offer comfort to the surviving spouse.

Moore's efforts prompted the U.S. military to set up family support networks and casualty notification teams of uniformed officers, which is currently used in today's units. The story was captured in Moore's book he cowrote with Joseph L. Galloway, *We Were Soldiers Once...And Young*, that was adapted into the film *We Were Soldiers*.

Besides the role of spouses and family readiness groups in the United States, Brown also addressed the prospect of adding chaplains to the Mongolian Armed Forces.

"The chaplain is the one who is there to boost up and help bring spiritual wellness," Brown said. "We want to convey that freedom of religion is absolutely essential. In our chaplain programs, we can offer all types of religions and help people meet their spiritual needs however they want to have them met."

Alaska National Guard Chaplain Richard Koch reflected on the potential impact of this initial discussion of adding chaplains to the Mongolian Armed Forces.

"This is a historical event," Koch said. "If they actually do succeed in establishing a chaplaincy, it's kind of neat that I was here to give a small shove and push them toward the future."

One of the biggest challenges the Mongolians face is stimulating community support from businesses.

Rich Owens, director of Employer Support for the Guard and Reserve in Alaska, shared his experiences as a business owner who supports military in his community. Owens is the owner of Tastee Freez, an Anchorage restaurant and ice cream shop.

"In Alaska there's a feeling of appreciation and esteem for our professional military," Owens said. "I think if we take something out of this meeting, it would be to come up with a better understanding of how their [Mongolian] businesses work, look at their capabilities, and think of ways we could suggest how to incorporate a cooperative agreement between the business community and the military community."

Khaan Quest 2009 is wrapping up, with a scheduled conclusion for Aug. 25. The purpose of Khaan Quest is to increase interoperability and planning expertise among participating nations, and to further develop the Mongolian Armed Forces' training center at the Five Hills Training Area. "In Alaska there's a feeling of appreciation and esteem for our professional military," Owens said. "I think if we take something out of this meeting, it would be to come up with a better understanding of how their [Mongolian] businesses work, look at their capabilities, and think of ways we could suggest how to incorporate a cooperative agreement between the business community and the military community."

The purpose of Khaan Quest is to increase interoperability and planning expertise among participating nations, and to further develop the Mongolian Armed Forces' training center at the Five Hills Training Area. Hello Commissioner and General ... I understand there has been a request made from APD for a military plane to take approximately 100 officers to Hoonah for the memorial service. I saw McHugh in the airport today right after I received a phone call from a friend who is an APD officer. McHugh explained to me that DMVA cannot do this as there are commercial planes available for the officers to purchase tickets to Hoonah; and, therefore, it would go against the economic laws. My friend says they were told that the Governor and Begich are working on them getting on a military flight. In fact, he received an email from APD with this information. I just wanted you both to be aware of the situation so that we can get the correct information out to officers. I don't want anyone to think the Governor is not trying to be helpful or preventing the military from transporting officers.

McHugh also let me know that AST had looked into chartering a flight, but due to the expense it did not seem justifiable for AST to do this. From my conversation with my friend, it sounds like many officers would personally purchase commercial tickets to Hoonah if they knew there was not another option.

Thanks for your help, and let me know if there is anything we can do to assist in these efforts.

Jack and Randy, here is the update on our RSA situation:

Nome Armory Roof Design: RSA process taking place. Money, all \$75,000, will be to DOTPF on Monday or Tuesday.

 $AMYA\ various\ projects:\ RSA\ taking\ place.\ All\ \$1\ million\ will\ be\ at\ DOTPF\ on\ Monday\ or\ Tuesday.$

Kodiak Armory Roof Replacement: seeking transfer of funds authorization from OMB to approve using money for Jewel Lake Armory, which was transferred to the Muni of Anchorage, to be used for this project. The Kodiak Amory has been reclassified by National Guard Bureau as a 50/50 match instead of 100% federal funding. We are short \$950,000 and the \$800,000 from the Jewel Lake Armory will cover almost all of that deficit.

Anchorage Armory Carpet: this is a 60/40 fed to state match project that is dependent on NDAA passage. We are in a holding until that bill passes in the lame duck session of Congress.

Anchorage RC Latrine project: also a 60/40 project that is dependent upon NDAA passage.

Upgrade Mandregan Interior: this converts the Mandregan building on Camp Carroll into a 200 man barracks. This is a 75/25 fed to state match project that is dependent upon passage of the NDAA.

In discussion with several of my Adjutants General Army Peers in other states, the conversation immediately has turned to issues within the Air Guard. Many have expressed problems of character assignation and efforts to undermine the confidence in leadership. A lot of this stems from the significant changes that are occurring in our Air Force as missions and funding changes. Many don't like it and as a result, many of their governors are receiving many electronic communications similar to those our governor is getting. I don't know if it is coordinated or not, but it does seem to be the trend.

I provide this to you, as this is an exceptional step for the Director of the Air National Guard to transmit such a pointed and directed e-mail. Usually NGB positions are very "vanilla". I certainly look forward to your continued guidance in addressing Air Guard leadership, but I think it would be very prudent for us to be very deliberate in our approach.
