

Elected Vice Chair in 2018, served as interim Chair when former chair was appointed Judge of the Superior Court (Fairbanks); Elected Chair for 4 consecutive years of my term.

Appointed in 2020; Attorney for three-person Board ensuring State compensation for victims of violent crimes. Acted as the Attorney to review, approve, and implement State of Alaska board policies and procedures to establish protocol for claim eligibility status and type of assistance; Work with Executive director to address staff issues, federal government audits, and approval of annual state and federal budget to ensure operations, payment of administrative expenses, and available monies to pay claims to victims. Evaluated hundreds of claims both on an emergency and regular basis, in addition to addressing numerous backlogged claims with the same high level of attention. Work with Commissioners and staff to approve claims for victims in accord with established eligibility protocol.
