

- Length of Stay: 17% stayed 0-6 days, 83% stayed 7-30 days
- 174 exited in HMIS: 16% exited to homelessness, 84% missing data

Catholic Social Services – Brother Francis Shelter – Oct - Dec

- 325 Individual Participants (unduplicated) people
- Length of Stay: 43% stayed 0-6 days, 32% stayed 7-30 days, 19% stayed 31-91 days, 6% over 91 Days
- 217 exited in HMIS: 22% exited to homelessness, 78% missing data

Henning Inc - Sullivan, Alex & Aviator – Oct – Apr

- 2026 Individual Participants (unduplicated)
- Length of stay: 30% stayed 0-6 days, 34% stayed 7-30 days, 23% stayed 31-91 days, 11% stayed 92 - 182 days, 2% stayed 183 – 265 days
- 1800 exited in HMIS: 8% (139) exited to Housing, 1.4% Temporary Destination, 33% exited to homelessness, 58% all other exits
