**STIPULATED SETTLEMENT AGREEMENT AND ORDER**

The plaintiff, the Alaska Black Caucus, and the defendant, the Municipality of Anchorage, stipulate, pursuant to Alaska Civil Rule 41(a)(1)(B), to resolve this case on the following terms:

1. By August 1, 2024, all patrol officers at the Anchorage Police Department shall wear a body worn camera whenever they are in uniform and on duty.
2. The defendant shall pay the plaintiff attorney's fees and costs of \$5,000 within 15 days of the execution of this Order, in full satisfaction of any and all claims for fees or costs.
