HJR 35	KELLY, KELLER, PEGGY WILSON, AND GATTO	Proposing amendments to the Constitution of the State of Alaska prohibiting passage of laws that interfere with direct payments for health care services and the right to purchase health care insurance from a privately owned company, and that compel a person to participate in a health care system.
HJR 36	RAMRAS	Proposing an amendment to the Constitution of the State of Alaska authorizing a contractual limitation on taxes related to the production of gas for the purpose of providing fiscal certainty for the construction of a natural gas pipeline.
HJR 37	CRAWFORD	Proposing amendments to the Constitution of the State of Alaska relating to the Alaska permanent fund, establishing the earnings reserve account, and relating to the permanent fund dividend.

SB 195	THOMAS	Relating to the repeal of the establishment of the Goldstream Public Use Area.
SB 196	DYSON	Authorizing the appropriation of revenue from the tax on motor fuel used in boats and watercraft for promoting boating safety.
SB 197	DYSON	Allowing pharmacists the right to refuse to refer, recommend, or dispense emergency contraceptives; providing immunity to a pharmacy for civil liability for a pharmacist's refusal to refer, recommend, or dispense emergency contraceptives; and prohibiting discrimination in employment against a pharmacist who refuses to refer, recommend, or dispense emergency contraceptives.

SB 204	DYSON	Relating to state employee health plans that give employees the option to select a federally qualified high deductible health plan and requiring employees who select that plan to establish a health savings account.

		newly proved gas reserves in the Cook Inlet sedimentary basin.
